11. FINANCIAL RISK ASSESSMENTS (FRAS) 2015 - 2016.

The Financial Risk Assessment Working Group met on 8 October 20214 to consider the current FRA's and after discussion it was agreed that no changes were required for the next financial year. It was noted that although reviewed annually the FRA's for 2016 – 2017 would require additional attention as this was when the amounts reduced significantly. It was also highlighted that the 5 year "term" of the FRA's was approaching which allowed expenditure on the items included when and where appropriate/required.

The Working Group acknowledged that the FRA's were progressing and being managed very well and that there was no need to alter or amend them at the present time.
