8. VIREMENT.

Because the RFO was able to negotiate a substantial reduction in the council's annual insurance renewal premium, the Insurance Budget (Cost Centre 14, code 236) has come in £5,615.91 under the amount contained in the 2013 – 2014 estimates.

The below unexpected expenditure has been required and members are asked to agree for these costs to be vired from the insurance budget to the council offices building maintenance budget (Cost Centre 14, code 251). These matters were informed to the Chairman of Finance and General Purposes Committee when they arose.

9. FINANCIAL RISK ASSESSMENTS (FRA) 2014 - 2015.

The FRA Working Group met on 23 October 2013 to review the FRA's, previously supplied to members, approved by the 17 January 2013 Town Council meeting (minute 373/12-13) to consider whether any amendments were required/necessary. After discussion the Working Group agreed that although a constantly fluid document the FRA's should be maintained at the level indicated and that the Town Council should not, at this point, be looking to add or increase anything contained in the FRA's. The Working Group applauded the standard and quantity of work that had gone into producing the FRA's and also the Town Council for the foresight and conviction it had demonstrated in progressing this significant/important project.

Recommended: That the Finance and General Purposes Committee

endorse the findings of the FRA Working Group and submit the FRA's to full Council for approval and

inclusion in the Estimates for 2014 - 2015.

10. ESTIMATES FOR 2014 - 2015.
