6. INFORMAL MEETING WITH DEVELOPER OF EASTERN QUARRY.

On 14 August 2013 the Chairman and Vice Chairman of the Planning, Major Developments, Transportation & the Environment Committee and the Chairman of the Recreation, Leisure & Amenities Committee met with the developer of Eastern Quarry and the Planning Officer from Dartford Borough Council to discuss the progress of the development.
