As part of the Town Clerks appraisal the timing of appraisals was identified as requiring adjustment as it was felt to be more appropriate for the appraisal process to follow the municipal year and cover the 12 month periods from April to April. This would then enable the Personnel Committee to set meeting dates for April/May each year to consider any cost of living pay increases as well as any performance related pay increases.

It is suggested that the ToR be amended so that the Committee meets in April/May each year (for the reasons above) and in October each year (to consider any items that may have arisen between April and October. Obviously this would not preclude the Committee from meeting as and when circumstances required during the year.
