

The Address Management & GIS Officer, Property Information (DBC) contacted the Town Council regarding suggested names (x9) for the first phase of the development, with a deadline for response of 6 June 2016 at the latest.

After having liaised with the Chairman of the Planning, Major Developments, Transportation & the Environment Committee, and noting that all x9 names were included in the list previously put forward by the Town Council, a response was submitted to DBC.

7. TRAFFIC CONGESTION IN DARTFORD (JTB) (p).

Further to the email dated 1 April 2016 attached are the minute from the Special Joint Transportation Board (DBC) meeting held on 12 April 2016.

The JTB met on 7 June 2016 and it is understood that a Working Party is to be established to investigate the possibility of what measures can be implemented in the short to medium term to mitigate the effects on Dartford and surrounding areas whenever a serious incident occurs at the Dartford Crossing or elsewhere, causing all the road network to become snarled up. The Working Party will be looking into possible smaller scale measures i.e. maybe shutting off an exit point during serious problems to stop rat-running in the area, or putting an extra set of traffic lights somewhere for use when traffic is severe etc. The Working Party will be made up of 4 people representing the 3 political groups at Dartford Borough Council. If members have any comments or suggestions these should be submitted to the Parish Representative on the JTB (Councillor R J Lees) who will ensure the Working Party receive them.
