#### 7. TOWN CLERK'S REPORT.

7.1 REPLACEMENT FENCING - MANOR PARK, SWANSCOMBE & SAXON COURT, GREENHITHE PLAY AREAS (p).

At the Financial Risk Assessment (FRA) Working Group meeting held on 22 June 2016, it was identified that funds were now available to replace fencing within the Town Councils parks and play areas. This follows the successful completion of replacement fencing at Knockhall Park, Greenhithe.

The attached pictures show the existing iron and wooden fencing at both sites. The specification has requested that bow top fencing, matching that installed at Knockhall Park. All the quotes have been obtained on a like for like basis with all 3 quotations from local fencing companies:-
