7. TOWN CLERK'S REPORT.

7.1 TREES TO TREASURE SCHEME - SUCCESSFUL APPLICATION.

The Trees to Treasure Team had sent confirmation that the Town Councils applications had been successful and as a result 154 mixed varieties of whips had been allocated. These would be planted at the Swanscombe Heritage Park, site in the usual manner, to give them the best chance of maturing.

7.2 RIGHT OF ACCESS TO REAR OF HERITAGE COMMUNITY HALL AND CRAYLANDS LANE ALLOTMENTS – UPDATE.

Further to minute 163/13-14 the owner of the former Stanley Ackers Hall site had supplied a key to the gate on 18 October 2013. When we tried to get keys cut from this the locksmith advised that it was not possible due to the specific type of key.

A letter was sent to the land owner advising him of this on 29 October 2013. On 31 October 2013 the land owner rang to inform that he had received our letter and would be fitting a new padlock and supplying us with keys.

7.3 DOG CHIPPING.

The Town Clerk has been liaising with the Campaigns & Education Assistant of the Dogs Trust to try to arrange sessions of free dog chipping. This would entail the Dogs Trust setting up a gazebo, if outdoors, and the public can then turn up (no appointments necessary) to have their dogs chipped free of charge. Due to the popularity of this scheme the earliest dates available are in March/April 2014.

7.4 PROJECT TO COMMEMORATE WW1 IN SWANSCOMBE AND GREENHITHE.

Further to minute 169/13-14 the attached quotations (A, B and C) have been received regarding the possibility of re-instating the old flag pole in Swanscombe Park.

The cost for a new 8 meter (7.15 meter above ground) flagpole would be £139.95 exc. VAT with flags costing approximately £60.00.
