7. DEPARTMENT FOR COMMUNITIES AND LOCAL GOVERNMENT (DCLG) - CONSULTATION ON EXTENDING THE REMIT OF THE LOCAL GOVERNMENT OMBUDSMAN TO LARGER PARISH AND TOWN COUNCILS (p).

The DCLG have submitted the above consultation which has a deadline for responses of 30 June 2015. The Consultation consists of 5 questions which are detailed within the document and listed on the response form (Annex A) on the last page.

8. 2015 ELECTION OF TOWN COUNCILLORS (p).

The Returning Officer, Dartford Borough Council, has advised of the results for the uncontested election for both Galley Hill Ward and the Swanscombe Ward. Statements of Persons Nominated have also been advised for both the Greenhithe Ward and the Knockhall Ward.

Members will note that the Swanscombe Ward has 1 seat vacant due to insufficient nominations.

9. VACANCY FOR SWANSCOMBE WARD (p).

Although not required to by law, to give public notice of vacancies in offices of the council arising from an insufficient number of candidates at ordinary election, the attached public Notice of Vacancy has been displayed requesting written expressions of interest.

Provided a quorum is present the Town Council will be able to co-opt onto the Council any person provided that person is qualified to be a councillor (pursuant to s.79 Local Government Act 1972) and is not disqualified (pursuant s.80 of the 1972 Act)., at the AGM on 21 May 2015.

The Project Manager, Advice Service Dartford, has informed the Town Council that funds received from the KCC Member for Swanscombe and Greenhithe will enable the surgeries currently provided at the Community Café, Church Road, Swanscombe to continue twice a month until December 2015 whilst attempts are made to secure further funding.
