- **Swanscombe Park:**

INFORMAL MEETING WITH DBC – Garage Conversion at NBG Allotments

17 May 2019 at 10.00am

PD issued copies of the plans for the conversion of the garage block area at the rear of Gilbert Close to flats with associated parking.

PD explained that the plan would be to undertake the initial improvements to the off street parking for the current Gilbert Close blocks and create a temporary access route for the allotment sites before breaking ground on the new units and closing off the existing access route.

All parties entered the allotment site and walked through the most appropriate route. PD confirmed that DBC would install gates, clear a new path through to the existing parking area. Any improvements made would be permanent and in essence give two vehicle access routes once the works are completed as the current gate would remain.

GP discussed about the need to move the current water points as these would hinder access. PD agreed this could be done as part of the works and bury the water system properly with new standpipes where needed.

PD agreed to send down a design team to finalise the details once planning was being pursued.

PD confirmed that planning was expected for all 4 garage sites up for conversion (Mead Road, Keary Road, Gilbert Close and Milton Road) around June / July, with the initial works being undertaken at Keary Road and Mead Road in August September.

GB questioned regarding information having been sent out regarding these proposal and the information being public.

PD confirmed that letters had been sent to Borough Councillors and that this had been through cabinet at DBC and was public information.

LH questioned regarding the impact on the works at Keary Road on parking and access to the allotment site there. PD agreed to consider any options the association could come up with to help with improved access negating the need to park in the grass area at the entrance to the access road or around the garage block itself.

PD agreed to come back with further dates to discuss both the plans for the improved access route at NBG and also any options to consider at Keary Road. PD confirmed he will liaise through GB when another site meeting could be arranged.
