6. COMMUNITY INFRASTRCTURE LEVY (CiL), DARTFORD BOROUGH COUNCIL (DBC) (p).

Further to minutes 329/22-23 (full Council 8 December 2022) and 51/21-22 (full Council 24 June 2021) the Infrastructure Levy Monitoring and Management Officer (DBC) has written advising that a proportion of the CIL receipts received from development/s within the Town Council area, for period 1 April to 30 September 2023, have been received and apportioned accordingly.

9. FINANCIAL RISK ASSESSMENTS (FRA) FOR 2023 - 2024 (p)
