10. APPLICATIONS FOR FUNDING FROM THE TOWN COUNCIL (p).

11. TOWN COUNCIL OFFICES COMMUNITY HALL – HEATING SYSTEM.

In consultation with the Chairman of the Finance & General Purposes Committee and to ensure a continuity of works and best value, a quote has been approved for essential repair works to the heating system at the Town Council Offices and Community Hall.

These works have totalled £7,477 and are being funded from the Financial Risk Assessments for this building. This has been decided under Financial Regulations 4.1 and 4.5, along with minute 319/23-24, due to the emergency nature of the works and the requirement to maintain a continuation of service (i.e. use of the hall).

All works have now been completed by the Town Councils approved contractor for plumbing and heating.
