Attached are photos from the corporate event that took place in partnership with North West Kent Countryside Partnership on Friday 8 March 2024.

The company who took part were Federated Hermes who completed the work to rake the new meadow area and also installed a stag beetle habitat on land adjacent to the pond entrance.

Unfortunately, the new wildlife camera that was installed on Wednesday 21 February 2024 was damaged shortly after being placed on site.

The camera has since been repaired and will be replaced on site in a more secure location.

7. HERITAGE PARK EVENTS (p).

Attached are the advertising for upcoming events planned at the Heritage Park. These are two volunteer planting days on the 8 and 9 May 2024, which are open to the whole community.
