12. ANNUAL GENERAL MEETING OF THE TOWN COUNCIL.

On the 4 April 2020 the Local Authorities and Police Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations came into force.

This legislation brought into effect the following key points:

- Enabling Parish and Town Council meetings to be held remotely
- Suspending the requirement for Town Councils to hold an Annual General Meeting before 7 May 2021
- Enabling all current appointments (Town Mayor, Chairman and membership
 of committees) to continue unchanged until 7 May 2021 or such time as the
 Parish or Town Council decides to change these.

Following consultation with the Town Mayor and Deputy Town Mayor the decision was made to suspend holding an Annual General Meeting until May 2021.

This would mean that all current appointments and committee structure remain unchanged until the Annual General Meeting is held.

Recommended: To note and endorse the decision to suspend the holding of an

Annual General Meeting until May 2021.

13. RESUMPTION OF TOWN COUNCIL MEETINGS (p).

Further to item 12 and in consultation with the Town Mayor and Deputy Town Mayor a decision was made to resume Town Council meetings, remotely, but as a single monthly full Town Council meeting.

This meeting process would work alongside the existing delegated authority granted under Section 101 (1) of the Local Government Act 1972. This would enable the Town Clerk, in consultation with the Town Mayor and Deputy Town Mayor, to make any time critical decisions requiring a decision prior to the next monthly meeting.

Members are ask to note and endorse this decision and agree to the attached schedule of meetings for the remainder of 2020 – 2021.

Recommended:

- 1. To note and endorse the decision to conduct monthly full Town Council meetings.
- 2. To agree to the continuation of delegated authority to the Town Clerk, in consultation with the Town Mayor and Deputy Town Mayor, to make any time critical decisions.
- To agree to the schedule of monthly meetings.

14. SPECIAL TOWN COUNCIL AWARD 2020 - 2021.

A suggestion has been proposed to amend the Town Councils Recognition Award scheme to look at specific examples of community work undertaken during the COVID-19 pandemic.

Members are asked to consider how this award process could be undertaken and when any award would be made.

The existing recognition award scheme requires nominations by 31 March each year, with the final award being made at the Annual Open Town Meeting.

15. CORPORATE TREE PLANTING.

Further to the successful tree planting even undertaken in February 2020 between North West Kent Countryside Partnership and Optimum Power Solutions, another request has been received from these two organisations to plant more trees in the Swanscombe Heritage Park.

At present, subject to government guidance, this is proposed for November / December this year. This would be planting approximately 100 saplings to continue the new woodland area within the site.

Members are asked to approve this project as the landowners of the Swanscombe Heritage Park.
