- 5. LOCAL POLICE MONTHLY UPDATES (p).

Kent Police have provided the attached monthly updates for February (these were previously emailed to all members).

It is hoped that PCSO Andrew Lewis will be able to attend the meeting to discuss the updates.

6. SPECIAL PANDEMIC HERO AWARD (p).

Further to minute 20/20-21, attached for members consideration are the nominations for the Special Pandemic Hero Award 2020 – 2021.

Nominations for this award have been running from July 2020 and closed on 31 March 2021.

It is recommended that the winner of this award is presented as part of the virtual Annual Open Town Meeting on Tuesday 4 May 2021.

Attached for members consideration is a draft certificate for the winner of the award.

7. ACCESS ROAD GULLIES - SWANSCOMBE CENTRE (p).

The access road to the side of the Swanscombe Centre serves several community facilities including the Swanscombe Centre itself, Craylands Lane allotments and Swanscombe Heritage Park.

The drains / gullies within the road are blocked and during heavy rain extensively flood the vicinity.

Initial investigations works have been undertaken to both attempt to clear the blockage and ascertain the route of the drain and the works required to remedy the problem.

The Town Council have now had a quotation to excavate the soft ground and install two new pipes from the gullies to the storm drain (map attached), at a cost of £3,375.00+VAT.

Members are asked to consider whether to have this work undertaken.

Members need to be aware that as no budget has been allocated for this the cost would have to be met from the monies within Community Infrastructure Levy budget that the Town Council currently holds.

Recommendation: To decide whether to commence with the works to

repair the drains with the access road adjacent to the

Swanscombe Centre.

8. ADDITIONAL BENCHES - SWANSCOMBE & BROOMFIELD PARKS (p).

The Town Council have received a request asking whether we would install benches outside of our play areas, to enable parents with dogs to sit and watch whilst their children play. The request has been made for both Swanscombe and Broomfield Park.

This would be in addition to the benches already located within the children play areas themselves. The benches the Town Council currently install across its sites cost £459.40+VAT per bench.

Attached for members information is an image of the current bench used and an overhead diagram of both play areas indicating the possible location for benches.

Members need to be aware that as no budget has been allocated for this the cost would have to be met from the monies within Community Infrastructure Levy budget that the Town Council currently holds.

Recommendation: To decide whether to install x 2 new benches outside

play areas in Swanscombe and Broomfield parks.

9. BOOT SCRAPERS - SWANSCOMBE HERITAGE PARK (p).

The Town Council have received a request asking whether we would install x 2 boot scrapers at the two walking entrances to the Swanscombe Heritage Park.

The Town Council currently has boot scrapers adjacent to kissing gates at both Broomfield and Knockhall Parks. The boot scrapers the Town Council currently install across its sites cost £284.62+VAT per scraper.

Attached for members information is an image of the current boot scrapers used and an overhead diagram of the entranceway indicating possible locations.

Members need to be aware that as no budget has been allocated for this the cost would have to be met from the monies within Community Infrastructure Levy budget that the Town Council currently holds.

Recommendation: To decide whether to install x 2 new boot scrapers at

the entrance ways to the Swanscombe Heritage Park.

10. TREE WORKS & REPLACEMENT TREES / COMMUNITY ORCHARD - SWANSCOMBE PARK (p).

As part of the works agreed within the 2019 tree survey, the large Leylandii in the corner of the bowls green at Swanscombe Park was scheduled to be felled. This work was delayed due to the pandemic and has now been scheduled for October 2021 to ensure that any cutting does not impact on the wildlife and nesting season.

When the decision was made to fell this tree, it was agreed to plant x 2 trees, at a more suitable location within the park.

Attached for members consideration is a report with some suggested replacements and a diagram of a possible location.

Recommendation: To note the delay to felling the Leylandii tree in

Swanscombe Park, and to decide on the species and

location for its replacement.

11. COMMEMORATIVE BENCHES (p).

The Town Mayor has submitted a suggestion to dedicate the new benches, planned to be installed within the picnic area within Swanscombe Park, to those who have lost their lives during the COVID-19 pandemic and / or to those key workers who went above and beyond to serve our community.

Attached for members consideration are some designs and costs for plaques that could be used.

Recommendation: To decide whether to dedicate the new benches for

the picnic area within Swanscombe Park to those who lost their lives and / or keyworkers who served the

community during the COVID-19 pandemic.

12. VE DAY 2021 - TOMMY SILHOUETTES (p).

In order to commemorate Victory in Europe (VE) Day 2021, an opportunity has arisen to purchase some lamp post hung tommy silhouettes.

Attached for members consideration is an image of the product, another showing how it could look on the street lights outside the Town Council offices.

Members are asked to consider whether to purchase this product and place it up for VE Day 2021 at a cost of £225.00 + Shipping.

Members need to be aware that as no budget has been allocated for this the cost would have to be met from the monies within Community Infrastructure Levy budget that the Town Council currently holds.

Recommendation: To decide whether to purchase a tommy silhouette to

be hung on the street lights outside the Town Council

offices to commemorate VE Day 2021.

13. NEW NOTICEBOARD - THE AVENUE GREENHITHE (p).

The Town Council have been approached by Dartford Borough Council (DBC) who have asked whether we would like to place a community noticeboard on a piece of land along The Avenue, Greenhithe, that DBC have recently renovated.

Attached for members consideration is an overview map showing the piece of land in question, along with a street view of the site.

Also attached are two example noticeboards including costings.

Members are asked to consider whether to install a new noticeboard at this location.

Members need to be aware that as no budget has been allocated for this the cost would have to be met from the monies within Community Infrastructure Levy budget that the Town Council currently holds.

Recommendation: To decide whether to install a new noticeboard at The

Avenue, Greenhithe, and what design to use.

14. NATURAL ENGLAND CONSULTATION - SWANSCOMBE PENINSULA (p).

Attached for members consideration is a letter from Natural England, along with supporting documents, indicating the enlargement of the Site of Special Scientific Interest (SSSI) at Bakers Hole, Swanscombe, to encompass the wider Swanscombe Peninsula area. The Town Council are being asked whether we wish to make comments on this change to the Bakers Hole SSSI.

Any comments must be made by 12 July 2021.

Members were previously sent this information on 15 March 2021.

Recommended: To decide whether to, and what wording to include, for

any comment to this consultation.

16. ANNUAL SAFETY INSPECTION OF PLAYGROUND EQUIPMENT (p).

Please find attached the results of the Annual Playground Safety Inspection. Members will see that most of the risk criteria ratings are L (low) or VL (very low).

Unfortunately due to issues with soft surfacing and also with timber play equipment the cost required is more than was budgeted for and Members are asked for the difference to be paid for from the Financial Risk Assessment monies currently held by the Town Council for surfacing.

The report also highlights some equipment that may require replacing in the future and Members are asked to take this into account when setting the annual estimates for next year (2022-2023).
