338/23-24. HIGHWAYS IMPROVEMENT PLAN (HIP) - UPDATE.

Further to minute 208/23-24 the KCC Road Safety Engineering Project Manager – Highways Improvement (West Kent) had provided information regarding the request to install wooden bollards in Swanscombe High Street from the southern extent of the zig-zag lines opposite the Co-Op, to the corner of the road at the junction with The Grove (but not beyond into The Grove).
