Further to minute 74/17-18 x2 back pack sprayers have been purchased (7 August 2017) and the Senior Groundsman/Gardener is making arrangements for employee 63 to undertake the final element of his formal Chemical Spraying training. This should help eradicate/reduce incidents of weeds being allowed to grow in areas causing damage that could result in expensive repairs being required (example photographs attached).

#### 7. TOWN CLERK AND RESPONSIBLE FINANCIAL OFFICER'S REPORT.

# 7.1 UNAUTHORISED ENCAMPMENT (UE).

Members will be aware that on Thursday 3 August 2017 (approximately 9pm) the Town Council were victims of an UE at Swanscombe Park (approximately 20 caravans and associated vehicles). Council Officers worked with the Local Police and the Enforcement Team at Dartford Borough Council (DBC) to ensure this matter was resolved at the earliest opportunity and this resulted in the UE vacating the park on Friday 4 August 2017 (approximately 5.30pm) with the park only being closed to the public for 2 hours on Saturday 5 August 2017 whilst the area was cleaned and declared safe. The financial implications incurred by the Town Council as a result of this incident were minimal.

#### Recommended:

- 1. That the actions taken by the Town Clerk in dealing with this matter be endorsed.
- 2. To discuss and advise accordingly.

## 7.2 PRUNUS (CHERRY) TREE – BROOMFIELD PARK (p).

Unfortunately the tree previously planted in Broomfield Park (minute 167/14-15) has died and will require replacing.

#### 7.3 NEW PLAY EQUIPMENT - BROOMFIELD PARK (p).

Further to minutes 317/16-17, 16/17-18 and 76/17-18 Ebbsfleet Academy undertook a survey of their students regarding the x3 options for new equipment, selected by the Recreation, Leisure & Amenities Committee from the x6 options previously provided, and the results are attached. Members will see that "Rota Glide, City Adventure Trail and Air Rider" proved to be the most popular receiving 59.78% of the votes cast.

To expedite the installation process, and in consultation with the Chairman of the Recreation, Leisure & Amenities Committee the equipment has been ordered and an installation date is awaited.

**Recommended:** To endorse the order being placed for the installation

of the "Rota Glide City Adventure Trail and Air Rider" in Broomfied Park (location previously agreed –

minute 76/17-18).
