Apologies for absence were received and accepted from Councillors' Ms L C Howes (holiday), Mrs C K Openshaw (unwell), Colin Newmarch (Community Safety Unit (CSU) Dartford Borough Council), PC Rob Payne (Kent Police), PCSO Kelly Shurmer (Kent Police), PCSO Steve Howard (Kent Police) and Billy Unsworth (KCC Community Warden, Swanscombe).

383/14-15. DECLARATIONS OF INTEREST IN ITEMS ON THE AGENDA.

There were none.

The Chairman gave the opportunity for the meeting to be adjourned at this point to accept questions from the public.

384/14-15. ITEMS DEEMED URGENT BY THE CHAIRMAN / MATTERS ARISING FROM PREVIOUS MINUTES AND THEIR POSITION ON THE AGENDA.

The Vice-Chairman had requested updates on three items from the last meeting:-

1. The status of the letter regarding obstructive parking (Chief Inspector Woodward).

District Commander Woodward advised that the letter was now being used and any calls that the Police had to attend, the letter would be put on the vehicles windscreen. Inspector Woodward confirmed that he would provide the Town Council with a copy of the letter.

2. An update on the "Action Day" held in Swanscombe and the possibility of a similar event in Greenhithe:

Sgt Sarah Tyler advised that the Action Day was successful. There had been a great deal of engagement with the community and positive feedback had been received. A further "Action Day" was planned for Greenhithe and Stone on 24 – 28 March 2015 and Kent Police requested suggestions of areas within Greenhithe for them to target.

3. Communication of reported crimes via the Neighbourhood Watch Schemes

Discussion took place on how to improve communications. After a lengthy discussion on this subject, Commander Woodward suggested it might be better to look at the current systems and processes and see if they could be improved.

Members were also advised that the CSU unit at Dartford Borough Council had requested areas in Swanscombe and Greenhithe that could benefit from the assistance of the Community Payback team.

385/14-15. TO CONFIRM AND SIGN THE MINUTES OF THE MEETING HELD ON 8 OCTOBER 2014.

Recommended:

That the Minutes of the Meeting held on 8 October 2014 be confirmed and signed as a true record.

386/14-15. TOWN COUNCIL'S PROBLEM LOG.

Members were provided with a copy of the incidents reported to the Town Council since the last meeting. Members were reminded that the Town Council should be made aware of any incidents reported to the police, in order for them to be added to the problem log. The RFO advised that the problem log was emailed monthly to the CSU at DBC and also to the Police.

Recommended:

387/14-15. BEAT OFFICER AND POLICE COMMUNITY SUPPORT OFFICERS (PCSO) REPORT.

Sgt Sarah Tyler provided members with a report from PC Robert Payne. She confirmed that daily patrols had been attending the leisure centre in relation to calls received regarding groups of young people congregating at side of building causing anti-social behaviour. The incidents had stopped. The PCSOs had been concentrating on vehicles parking on the zig-zag lines in the High Street. She confirmed that mopeds and off road motorcycles were becoming a problem again and the anti-social behaviour car was therefore making a visible presence in the

area. She urged everyone to forward any details of motorcycles seen onto the Police. A drugs warrant had been executed in Ingress Park. A theft warrant had also been executed with two people being arrested. Operation Eliminate, an initiative to eliminate burglary had been running using Special Constables. With high visibility patrolling, there had been a noticed reduction in overnight crime. She confirmed the letter being issued to obstructively parked vehicles was in its early stages and would therefore report information regarding this at the next meeting. The Police also wished to progress the "Allotment Watch" initiative but there appeared to be no interest. Councillor B E Read advised that the council was meeting with the Allotment Association and would advise them of this initiative.



Please find monthly bulletin highlighting some of the work the team have undertaken throughout the prior month:

February 2015

Please find below a summary of what the Community Policing Team for Swanscombe and Greenhithe have been involved in during February 2015. Please feel free to disseminate to the Town Council.

- > PC PAYNE supported private parking enforcement Officers at Asda, Greenhithe. Enforcement Officers issued 8 tickets to vehicles parked in bus turn around to the rear. This is not a parking area.
- PC PAYNE has patrolled and dealt with vehicles using the Fast Track bus route into Ingress Park, Greenhithe. Local residents thanked the local team for their efforts.
- > The Local team supported Trading Standards Officers at two shops within Swanscombe High Street. This resulted in a quantity of counterfeit smuggled cigarettes being recovered and seized.
- PC PAYNE arrested two Swanscombe males on suspicious of Burglary other than a dwelling during a warrant conducted by the local team.
- > PC PAYNE arrested one of these males a second time on suspicious of Burglary other than a dwelling. The male was subsequently charged and bailed to Court.
- > PCSO HAILEY supported the Speed Watch Scheme in Ingress Park during a recent shift. As a result a driver is being dealt with for overtaking a bus and traffic island.
- > Stone and Greenhithe Action week preparation remains on-going by the team.

Please find our monthly bulletin highlighting some of the work the team have undertaken throughout the prior month. I have checked with our media Officer and this can be disseminated to all Town Councillors and Neighbourhood Watches if you wish.

March 2015

Please find below a summary of what the Community Policing Team for Swanscombe, Greenhithe and Stone have been involved in during March 2015. Please feel free to disseminate to the Town Council and Neighbourhood Watch.

- > The local team assisted with the execution of six simultaneous search warrants across Dartford including three within Swanscombe. This was in relation to a number of reported theft of motorbikes throughout Dartford. As a result:
 - A teenage boy received a 16-month prison sentence yesterday for a number of offences.
 - A man was arrested and charged with handling stolen goods
 - Two teenage boys were arrested and have been bailed whilst enquiries are conducted.
 - Stolen property was identified and seized by police during the warrants.
- > The team conducted a targeted operation throughout Stone and Greenhithe. Local officers and police community support officers worked alongside other partner agencies to deal with a variety of issues raised to the team by the community. Here is a summary of what the team took part in/dealt with:
 - Increased patrolling within the two wards focusing on issues raised by the community such as theft
 of mail, theft of pedal cycles, and anti-social behaviour.
 - Police checked more than 200 vehicles for their speed as part of a speed enforcement initiative in Ingress Park Ave, Greenhithe, London Road, Stone, and St James Lane Stone.
 - A number of drivers stopped and dealt with for driving on the Greenhithe Fast Train route.
 - Dartford Borough Council Parking Officers and officers attended Stone St Mary's Primary School, Knockhall Primary School Greenhithe and The Brent Primary School. This was in relation to reports of congestion and dangerous parking at the beginning and end of the school day. A number of tickets were issued by Dartford Council Enforcement Officers across the three schools.
 - Community engagements: Officers and the Crime Prevention Panel held a joint surgery at Asda in Greenhithe. The local team also conducted a crime prevention talk at the Stone Parish Council's Tea and Coffee Morning, a visit to a residential care home in Stone, and attended Greenhithe's Community Café.
 - Officers assisted Dartford Borough Council licencing Officers in licence checks at seven public houses/stores within Stone and Greenhithe.
 - Members of the local team assisted member of the community in conducting a riverfront litter pick in Greenhithe.

Please find below a summary of what the Community Policing Team for Swanscombe and Greenhithe has been involved in during May 2015. Please feel free to disseminate to the Town Council and Neighbourhood Watch.

May 2015

- ▶ PCSOs have been dealing with nuisance off-road motorbikes in Swanscombe Heritage Park. A number of Section 59 warnings have been issued to individuals and their bikes as a result. If the riders are stopped again and found to be using their vehicles illegally they risk prosecution and having their bikes seized.
- PCSOs located and seized a suspected stolen quad bike after reports were made to Kent Police of a quad bike driving around Swanscombe.
- > The team has been dealing with anti-social behaviour within Greenhithe's car parks. As a result an individual was issued with a cannabis warning and a further individual was arrested for possession of a Class B drug.
- > The team has been dealing with reports of anti-social behaviour within Ingress Park's car parks.

As the weather warms up, avoid leaving house doors and windows open or unlocked when working in the garden. Don't make your property an easy target.

I would like to thank our community for reporting issues to the team. Many of the incidents we have been dealing with recently have come from members of the community contacting us. Please be assured that any information provided to us will be kept confidential.




