Kent Minerals and Waste Sites Plans - Call for Sites

Regulation 18 Town and Country Planning (Local Planning) (England) Regulations 2012.

Notification of Preparation of the Kent Minerals and Waste Sites Plans and 'Call for Sites'

Following the adoption of the Kent Minerals and Waste Local Plan 2013-30 (KMWLP) in July 2016, the County Council is now commencing work on the preparation of two spatial sites plans (known as the Kent Minerals and Waste Sites Plans). The Sites Plan work is a key part of the plan making process and will allocate sites suitable for minerals and waste development in Kent. As planning application decisions are normally determined in accordance with the Development Plan, the Site Plans will have an important role to play in the management of future mineral and waste management development in the county. The County Council is now giving relevant stakeholders an opportunity to propose sites for allocation within them (known as a 'Call for Sites').

Whilst work was previously undertaken on the Sites Plans (including a Call for Sites in 2010, and a Preferred Options Consultation in 2012) it is now considered necessary to begin this work again for the following reasons:

- The elapse of time since 2012 may have resulted in changes to landowner and promoter aspirations for a site which may affect its deliverability at this time
- Changes in the way certain land is protected from impacts caused by development such as new or revised Sites of Special Scientific Interest (SSSI) which may affect a site's suitability
- Some sites previously considered as suitable have since obtained planning permission and/or been developed and so are no longer available
- Changes to the overall type and quantum of minerals and waste management development requirements that sites identified in the Sites Plans need to accommodate (as specified in the adopted KMWLP). This includes separate consideration of the need for further landwon soft sand and sharp sand and gravel reserves.

In light of the above it should be noted that previous work which assessed the suitability of a site cannot be taken as an indication of its current suitability for allocation in the eventual Sites Plans.

The website also includes links to the Site Selection and Identification Methodology. This document sets out the types of minerals supply and waste management facilities which would be accommodated on the allocated sites, as well as the methodology to be employed when assessing a sites' suitability for allocation. Please contact us if you have any comments on the types of site to be included in the Sites Plans and the Site Selection and Identification Methodology.

The County Council is also currently consulting on an updated Statement of Community Involvement (SCI) as well as a Minerals and Waste Safeguard Supplementary Planning Document (SPD).

The Statement of Community Involvement sets out how and when communities (you, businesses, community groups, and members of the public) can most effectively get involved with the town and country planning issues that concern them. As well as the Minerals and Waste Local Plan, it sets out opportunities for getting involved with the planning applications the County Council determines. Talbot – Richard Talbot is a descendant of Roger of Montgomery, 1st Earl of Shrewsbury. Richard Talbot became wner of the 'Manor of Swanscombe' in 1316 when he married the sister of the John Comyn of Badenach. It was in the Talbot possession until 1342.

Mortimer – In 1342, possession of Swanscombe passed to Lord Roger Mortimer and in turn to his great-grandson Edmund Mortimer and then to Richard, Duke of York. The Mortimers held possession until 1424.
