Parks Report: RLA 5 February 2015

## Swanscombe Park:

All hedge cutting has been completed. A burnt out litter bin has been replaced. The shrubs recently planted in the old rose bed seem to have settled in.

There was a break in to one of the park buildings in December and a double

glazed window in the bowls pavilion was broken.

The relatively mild winter weather has meant that the grass has continued to grow and the Town Green has not had its usual rest period. Consequently the Green is showing signs of disease and moss has thrived in the conditions. We are treating the Green for both problems and expect to have it in good playing condition by the time the season starts. The wooden boards around the bowls green ditches are being replaced as necessary.

Maintenance to benches is due to take place.

## Manor Park:

Leaf clearing has been done. We intend to top up the soil in the worn parts of the play area.

## Broomfield:

The football pitches are playing well and are in good condition for this time of the season. Burnt out dog waste bins and litter bins have been replaced. Broken fences in both Broomfield and Neptune Park have been repaired.

## Heritage Park:

Shrubs encroaching on footpaths have been cut back.

## Knockhall:

There are still some problems with the junior football pitch retaining water in some areas but the drainage work undertaken last summer and regular spiking combined with the application of sand has kept it playable so far this season. Issues have arisen with the unauthorised use of marked out pitches in recent weeks.

## Spring Vale:

Agreed tree works have been carried out. Parks staff have cleared two van loads of fly tipping that has been dumped in the area.

## Valley View:

Leaf clearing has been completed. Trimming of overhanging tree branches is due to take place.

## Saxon Court:

All hedge cutting has been completed.

## Other Areas:

Shrub cutting has been carried out at the Council Offices, the Leisure Centre and Craylands Car Park.

# 7.4 UNAUTHORISED USE OF KNOCKHALL RECREATION GROUND (p).

The Town Council have been aware (since pre-Christmas) that a group of 10-15 adult males have been bringing their own small goals and playing/training across the marked out adult pitch on Saturday mornings (10.30 or 11.00am for approximately 1 hour). The Parks Staff have approached them and advised them that unauthorised use is not permitted and that if they wished to hire the facilities they should contact the Council offices/. Despite this they have continued to use the area. A name, address and mobile phone number was obtained from the gentleman who was in charge (captain/chairman).

The Town Clerk has rung and spoken to the gentleman and attempted to clarify that the facilities were owned and managed by the Town Council and that other organisations hired the facilities and that if they wished to use them they should apply to the council in the usual manner. Unfortunately this appeared to have no positive effect and the conversation became quite hostile and abrasive.

The issue has been reported to the Police and Community Warden but the Police have advised that it is a civil matter.

The attached letter has been sent to the address we have been given and a copy has also been handed to the group by the parks staff. The attached signs have been ordered (x2) and are hoped to be in place very soon.


During the conversations with the Parks Staff the group claimed that they had responded to the council's letter and that they wanted to meet with the Town Clerk. To date no response or correspondences have been received by the Council office.



USE OF KNOCKHALL RECREATION GROUND FOR ORGANISED ACTIVITY.

I am writing further to our telephone conversation on 10 December 2014.

Please be aware that Knockhall Recreation Ground, Knockhall Road, Greenhithe, Kent DA9 9HE is owned and managed by Swanscombe and Greenhithe Town Council and as such all organised activity must be authorised by the Town Council in advance.

I appreciate that there are often mis-conceptions about public parks so I would like to draw your attention to the following pieces of legislation:-

Section 56 (5) of the Public Health Act 1925 states:-

56 Further powers as to parks and pleasure grounds.

(5)When any part of the park or ground has been set apart by the local authority for the purpose of cricket, football or any other game or recreation, under paragraph (b) of subsection (1) of the principal section, the local authority may charge reasonable sums for the use thereof for that purpose.

- Section 19 (2) of the Local Government (Miscellaneous Provisions) Act 1976
   also states:-
  - 19 Recreational facilities.
  - (2)A local authority may make any facilities provided by it in pursuance of the preceding subsection available for use by such persons as the authority thinks fit either without charge or on payment of such charges as the authority thinks fit.

As I attempted to clarify during our conversation the Town Council bares the cost of the maintenance and upkeep of the land and therefore has the right to place restrictions as necessary to avoid unreasonable costs or prevent an unsustainable outcome.

With all of the above in mind I respectfully request that you cease your unauthorised use of the land with immediate effect.

Please do not hesitate to contact me if you would like to submit a formal request to hire the facilities.

I am writing on behalf of a few working professionals resident in Swanscombe and Greenhithe.

We wish to make our grievances known to higher authorities in this council regarding the recent treatment meted out to us while enjoying public services available to us as residents.

We have occasionally sought to make use of public services legally entitled to us as residents, in particular, we would like to be able to entertain ourselves on weekends and receive the health and therapeutic benefits that go with regular exercise, and this had not been a problem for about 18 months, however, over the past 6 months, we have found our efforts frustrated by persistent reappearance of an individual who claims to represent the Swanscombe and Greenhithe town council.

While occasionally trying to enjoy some casual football on Saturdays in the Knockhall Park, we are regularly approached and ordered to change our playing location without being given full and clear reasons. In the initial stages, the instructions delivered to us by a young man, who arrives in a council vehicle was that we had to offer some monetary consideration to the council to make use of the park, which we happily agreed to but our efforts to make payments have been thwarted giving one excuse after the other i.e. payments can only be made at specific times of the year. We have visited the council website for more information but there is no mention of payment of the use of the park.

The next excuse was that a certain part of the field was reserved for 'children'; despite some of us having children who would also like to run around with us on Saturdays, we complied and moved to another section of the grounds. Again this was not good enough as we are now being told that the pitch has been reserved and we are not allowed to play there as well. On the average we are usually about 10-12 persons and cannot occupy a full pitch, we only play in a small area which we cone out for ourselves.

I would like to reiterate the point that we are 'not' a professional team, nor authorized by any football association in the country, we all work full time jobs, are family men and some of us can not even make it every weekend due to job commitments. When we arrive on Saturday morning; there is acres of space for everyone wanting to use the grounds, we have never disrupted any activity taking place, we have never made any trouble or given anyone reason to believe the we are constituting a nuisance, it has been almost 2 years since we started using the park and till date there has not been damage to any property or reports of unruly behaviour. This leads me to believe that this persistent harassment is being fuelled by something else, I wonder if the fact that most of us are of ethnic minority background has anything to do with this. We are fully aware that other residents in the area are entitled to use public services, and we are strongly aggrieved over the impression that as residents, we are excluded from enjoying the same public services as others. I have attached a letter hand delivered to my colleagues on the 17/01/2015 indicating that we can submit a formal request to hire the facilities; however over the last one year or so we have made several attempts to do this but as earlier stated there is always an excuse why this is not possible again leading us to believe that we are not welcome there.

We write to you in good faith and would appreciate your investigation into the matter to guarantee us our public rights and identify all those who seek to deprive us of these services by bullying us off the premises.

Many thanks for your recent letter dated 20 January 2015 and referenced GJ/SA/Ojobo.

Since just before Christmas 2014 it came to our attention that a group of gentlemen were using Knockhall Recreation Ground to play football matches on Saturday mornings without any prior authorisation from the Town Council. A member of our Parks Staff approached the group and advised them that the area they were using was part of the football facilities that the Town Council manage, maintain and hire out to clubs and should not be used without prior authorisation from the Town Council. This, and subsequent advice from the Town Council, was ignored and the group continued to play (bringing their own equipment) across the clearly marked out football pitches.

The group gave the following contact details:-

When I rang Mr he said he was the Chairman/captain of Divert Lanes FC. I tried to explain that the areas of the park they were using were managed and maintained by the Town Council for hirers of the facilities and if they wished to use these areas they could apply to the council in the normal manner. Unfortunately Mr was not satisfied with my advice and informed me they would continue to use the park. I then sent Mr the letter dated 5 January 2015 and, to date, have not had any response.

The Parks Staff have approached the gentlemen each time they have been witnessed using the area (Saturday mornings approximately 10.30/11.00am) and it has been brought to their attention that signs are displayed (similar to the attached example) advising that the Town Council owns and manages the area and that organised activity requires the authorisation of the council.

We have tried to advise the gentlemen that they can use parts of the park that are not marked out for hirers (we have adult teams that hire the large pitch and junior teams that hire the small pitch) but this has been ignored.

Hirers of the football pitches are required to submit their requests to the Council by the end of May for consideration by the Recreation, Leisure & Amenities Committee in June each year. Casual hire can also be arranged throughout the year with details of the costs available from the council offices or via the home page of the council's website.

The content of the letter you have forwarded concerns me as:

- we do not have appeared to have received any correspondences from the group despite my letter, dated 5 January 2015 asking that I be contacted if the group wanted to submit a formal request to hire the facilities:
- we have always been courteous and polite in our communication/s with the group;
- the contact name used appears to be different to that previously provided to us by the group?

Unfortunately the letter supplied by you from Dr Ehighale Ojobo does not contain his address so I am unable to contact him directly, could I therefore respectfully request that you advise Dr Ojobo that I am more than happy to discuss this with him and to assist with any application he may wish to make to hire the areas of the park marked out for football. Obviously if Dr Ojobo's contact details were available it would make dealing with this matter much easier so any assistance you are able to provide would be greatly appreciated.




# "We are Watching You" Dog Fouling Campaign

## We're watching you ... the background

From the charity's 60 years of experience, Keep Britain Tidy knows what an emotive issue dog fouling is and how much it matters to people. As it is often cited as a key area of complaint and dissatisfaction from residents, we know how much it matters to you too.

That is why we looked for an innovative way to tackle dog fouling and help to make positive changes to people's behaviour. Our research showed that some dog owners act irresponsibly when they think they aren't being watched. So as part of our Defra-funded "Social Innovation to Prevent Littering" programme we tested this idea and trialled a way to use it to reduce dog fouling.




We worked with 17 land manager partners, across 120 dog-fouling hot-spot sites, to trial this innovative glow-in-the-dark eyes posters. We monitored dog fouling incidents both at the target sites where the posters were displayed and at displacement sites up to 100m away. Overall the experiment showed a 46% reduction in dog fouling incidents.



We trialled variations of the poster, all with the same glowing eyes and "thoughtless dog owners, we're watching you" message, but each with a slightly different angle. So whether your Authority is currently focused on an enforcement message, or would like to use positive reinforcement or peer influence to make your point, we have different posters to suit your needs. Each poster type showed a greater than 40% reduction in dog fouling incidents.

## We're watching you ... the campaign

Now we have done the research, we want as many partners as possible to take part in our national campaign to reduce dog fouling around England. We launched the campaign with over







twenty new partners in November 2014 and will continue to roll out the campaign (including a relaunch in March 2015).

The press and public have shown great interest as we've launched the campaign, and coverage has included national press (eg the telegraph), national TV (eg Good Morning Britain and BBC 1), national radio (eg Five Live), a range of regional press and wide web/ social media coverage.
