## 6. KENT COUNTY COUNCIL (KCC) - CONSULTATION ON PERMANENTLY EXPANDING THE CRAYLANDS SCHOOL (p).

KCC have issued a consultation on permanently expanding The Craylands School, Craylands Lane, Swanscombe, DA10 0LP from a one form entry primary school (intake of 20 children into the Reception Year) to a two form entry primary school (intake of 60 children into the Reception Year) from September 2016.

The public consultation runs from 18 January to 22 February 2016.

#### 11. DRAFT BUDGET STATEMENT 2016 – 2017 (p).
