#### Recommended:

- That specifications / quotations be sought for the installation of container style units to provide changing facilities and potentially a café. This would include business plans for how they would operate.
- That should funding not be in place for either a rebuild/ refurb by January 2026, then an item be placed on the agenda to endorse the decision to pursue the demolition of the existing building and installation of container units, subject to funding.
- 4. That a draft publicity document be approved, to be released via the Town Councils website and social media feeds following the meeting, to update the public on the decisions made.
