#### 5. STAFFING MATTERS.

Employee 57 resigned on 6 June 2024 with a last day of service being 6 September 2024. Following the new posts being advertised and interviews being held on and 74 started on 5 August 2024 and have settled in very well with no reported issues. The probationary periods are scheduled to end on 5 February 2025.
